Eligibility

Award Category 1 and 2

- An Organization/Company working in the production of construction equipment (OEM) and must be in the line of business for minimum 3 years as on March 31, 2022
- Domestic Category: Organization/Company should have a legal entity registered in India
 - Registered as a public or private limited company under the Indian Companies Act,
 1956
 - Registered as a partnership firm under the Indian Partnership Act, 1932
 - A public sector undertaking created under an Act of the Parliament/State Legislature
- International Category: Organization/Company should have HQ outside India but operations in India

Category 3

- An Organization/Company working in the production of construction equipment (OEM) and must be in the line of business for minimum 3 years as on March 31, 2022
- Domestic Category: The CEO must be working for more than 3 years with a legal entity registered in India and have handled the portfolio for minimum three year as on March 31, 2022
- International Category: The CEO must be working for more than 3 years with a legal entity registered outside India and have handled the portfolio for minimum three year as on March 31, 2022, including Indian Operations

Category 4

- An Organization/Company working in the production of construction equipment (OEM) and must be in the line of business for minimum 3 years as on March 31, 2022.
- Organization/Company must be in association with channel partners/distributors for the last three financial years as on March 31, 2022.

Definitions, Guidelines, Rules and Regulations, Receipt of Entries

Definitions

- Awards: Equipment Times Awards 2022
- Ark Events & Media Pvt. Ltd.: Organizer
- Applicant Company must be legal entity established in any one of the three modes:
 - (a) Registered as a public or private limited company under the Indian Companies Act, 1956
 - (b) Registered as a partnership firm under the Indian Partnership Act, 1932
 - (c) A public sector undertaking created under an Act of the Parliament/State Legislature.
- It is necessary for the applicant company to complete three years of operations. So, the applicant must furnish statements of accounts for the financial years 2017-18, 2018-19, 2019 -20, 2020-21.
- For diversified companies, it is necessary to submit annual revenue report by each segment.
- A construction equipment company that fulfills in-house requirements of the group and does not cater to the open market is excluded from the scope of this selection.
- Nomination categories as defined in the awards category.

Guidelines

- It is necessary to send responses to all the columns (that are relevant to your company/business) in the form.
- Applicant should sign relevant page only.







- Applicant should substantiate his/her (company) candidature by providing necessary documents like Annual Reports, Brochures, Reviews, or any other material that supports company's candidature for awards.
- It is suggested to keep a Xerox copy of completed nomination form.

Rules and Regulations

Participation:

- o It is necessary for applicants to complete the nomination form based on their Indian operations if in case they have operations both in and outside India.
- Applicants should be submitted by the lead partner.

Receipt of Entries

- It is necessary to have signs of two officers like MD, CEO, CFO, COO or Company Secretary
 of the organization on the nomination form.
- Award Management Committee will not be responsible for entry forms that are lost in transit or received late.
- It is mandatory to file nomination form in English only.

Incorrect Information

- o If any information furnished by an applicant is found incorrect in, then the participant will not be eligible for participation in the Awards.
- o If the Award Management Committee asks for proof of information provided in the nomination form, the applicant should be able to provide the same.

Selection of Winners

- An independent jury will select winners.
- o The jury's decision is final and will be binding to all applicants.
- Liability: The Company cannot and shall not be held accountable / liable for any disruptions / stoppages / interruptions or cancellation of the Awards or its ceremony on account of any factors beyond its control
- Acceptance to Rules & Regulations
 - o The applicant needs to read rules and regulations stated herein.
- The nomination form duly signed by the applicant will be considered as their acceptance of these rules and regulations

Final Nominations should be received by ARK Events and Media by September 19, 2022. Nominations would be disqualified if not accompanied with relevant supporting documents with the explanations provided towards nominations. Nomination to be filed only with the signing authority.
